CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That the ALDER SLOPE DITCH CO., a corporation, by Sam Litch, Pres., of Enterprise, State of Oregon, has a right to the use of the waters of Hurricane Creek, a tributary of the Wallowa River, for the purpose of the irrigation of 3,422.1 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, at pages 140, 141, 142 and 143; that the priority of the right hereby confirmed dates from 4:00 p. m. of November 30, 1901; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, of, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 56 acres in the NW 1/4 NW 1/4 (Lot 4) of Section 5; 8 acres in the NE 1/4 NE 1/4 of Section 6, Township 2 South, Range 44 East of Willamette Meridian.
