CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOS A. and PATRICIA KOENIG

of Rt. 1, Box 185, Stayton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Detroit Reservoir constructed under Permit No. R-1625

a tributary of Willamstte River

for the purpose of

irrigation of 39 acres

under Permit No. 26633 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 3, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 83.85 acre feet is subject to the terms of Contract No. 14-06-100-1067, dated March 15, 1960, between the United State of America through the Bureau of Reclamation and the applicant, a copy of which is on file in the office of the State Engineer, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the diversion from River Lot 9 (M14 NE4) Section 13, T. 9 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - of one cubic foot per second per acre, a diversion of 2½ acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 83.85 acre feet per year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres Mi SE.

6.0 acres M 3 SE 3 27.5 acres SW 3 SE 4 Section 12 5.5 acres NW 4 NE 3

Section 13 all as projected within Hause DIC 49 T. 9 S., R. 1 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 18 chains N. of the SW corner of the John Hause, Claim No. 49;
running thence E. 20 chains to the E. line of said Claim No. 49; thence N. along said
E. line 11 chains; thence W. 20 chains to the W. line of said Claim; thence S. 11
chains to the place of beginning. Save and except therefron: Beginning at a point
18 chains N. of the SW corner of the John Hause Claim No. 49; running thence E. 40
rods; thence N. 3 rods; thence W. 40 rods to the W. line of said Claim; thence S.
3 rods to the place of beginning.

AISO: Beginning at a point 10 chains E. of the SW corner of the John Hause Claim No. 19; running thence E. 10.0 chains; thence N. 18.0 chains; thence W. 10.0 chains; thence S. 18.0 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
