**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That HAROLD L. MENDENHALL**

of Route 2, Box 79, Willamina, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamina Creek

a tributary of South Yamhill for the purpose of irrigation of 40.0 acres

under Permit No. 26213 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 24, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Allen DIC 37, Section 24, T. 5 S., R. 7 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.4 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Allen DIC 37  
1.6 acre NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Burford DIC 44  
17.3 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Burford DIC 44  
6.2 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Burford DIC 44  
0.3 acre SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Burford DIC 44  
0.1 acre SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Allen DIC 37  
4.7 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Burford DIC 44  
13.5 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Burford DIC 44  
Section 24  
4.4 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Burford DIC 44  
Section 13
