CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD H. HURSH

of Huntington, State of Oregon, has a right to the use of
the waters of Durbin Creek for Tract #1; Burnt River for Tract #2
for the purpose of irrigation 58

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Baker County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 8, at page 134; that the priority of the right thereby
confirmed dates from 1864 for Tract #1; 1866 for Tract #2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed Three acre feet per
acre during any irrigation season, (with the further limitations contained in
Paragraph 64 of said Decree.)

A description of the lands irrigated under such right, and to which the water is appurtenant
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

2 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$

TRACT #2

(NOTE: 15 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$ and
8 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$ also
irrigated from Durbin Creek
under date of 1864.)

This certificate, together with the certificate issued to Oregon Portland Cement
Co., is issued to supersede that certain certificate issued to Harold H. and Marguerite
E. Hursh and recorded at page 12297, Volume 11, State Record of Water Right Certificates,
the right for the irrigation of 5 acres of land under said certificates having been
transferred to Oregon Portland Cement Company for manufacturing purposes by order of
the State Engineer dated April 11, 1949. This certificate also confirms a change in
place of use for land in Tract #1 approved by order of the State Engineer entered
February 3, 1945.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
