CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That BIG BEND WATER DITCH COMPANY, a corporation, by Fred W. Falconer, President, of Joseph, State of Oregon, has a right to the use of the waters of Wallowa River and Dawson Planing Mill Waste Water, for the purpose

of the irrigation of 3,197.5 acres of land, domestic and stock use; that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, at pages 145,146,147 and 148; that the priority of the right hereby confirmed dates from July 1, 1902; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed $1\frac{1}{2}$ acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 80 acres in the $N\frac{1}{2}SE\frac{1}{4}$; 40 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ and 22 acres in the $SE\frac{1}{4}SE\frac{1}{2}$ of Section 21, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 2: 30 acres in the $NE\frac{1}{4}NW\frac{1}{4}$ and 40 acres in the $NW\frac{1}{4}NW\frac{1}{4}$ of Section 15: 39 acres in the $NE\frac{1}{4}SW\frac{1}{4}$; 40 acres in the $NW\frac{1}{4}SW\frac{1}{4}$; 40 acres in the $SW\frac{1}{4}SW\frac{1}{4}$; 33 acres in the $SE\frac{1}{4}SW\frac{1}{4}$ and 2 acres in the $NW\frac{1}{4}SE\frac{1}{4}$ of Section 10, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 3: 160 acres in the $NE\frac{1}{4}$ of Section 4: 35 acres in the $NE\frac{1}{4}NW\frac{1}{4}$; 40 acres in the $NW\frac{1}{4}NW\frac{1}{4}$; 80 acres in the $S\frac{1}{2}NW\frac{1}{4}$ and 10 acres in the $NW\frac{1}{4}SW\frac{1}{4}$ of Section 3, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 4: 80 acres in the $N\frac{1}{2}SE\frac{1}{4}$; 31 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ and 40 acres in the $SE\frac{1}{4}SE\frac{1}{2}$ of Section 4, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 5: 40 acres in the $SW\frac{1}{4}NW\frac{1}{4}$; 30 acres in the $SE\frac{1}{4}NW\frac{1}{4}$; 80 acres in the $N\frac{1}{2}SW\frac{1}{4}$ and 14 acres in the $NW\frac{1}{4}SE\frac{1}{4}$ of Section 15, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 6: 40 acres in the $NW\frac{1}{4}NE\frac{1}{4}$ and 160 acres in the $NW\frac{1}{4}$ of Section 22: 80 acres in the $S\frac{1}{2}SW\frac{1}{4}$ and 23 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ of Section 15, Township 2 South, Range 45 East of Willamette Meridian. (of the above described land, 15 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ of section 15 is supplemented by water from Farmer's Ditch.)

Tract No. 7: 20 acres in the $NE\frac{1}{4}NE\frac{1}{4}$; 35 acres in the $SW\frac{1}{4}NE\frac{1}{4}$; 40 acres in the $SE\frac{1}{4}NE\frac{1}{4}$ of Section 29, Township 2 South, Range 45 East of Willamette Meridian. (Irrigated from Big Bend Ditch only)

Tract No. 8: 20 acres in the $NE\frac{1}{4}NE\frac{1}{4}$; 40 acres in the $NW\frac{1}{4}NE\frac{1}{4}$ and 5 acres in the $SW\frac{1}{4}NE\frac{1}{4}$ of Section 29, Township 2 South, Range 45 East of Willamette Meridian. (Supplemented by Dobbin and Wrenn-Dobbin Ditch)

Tract No. 9: 40 acres in the $NE\frac{1}{4}SW\frac{1}{4}$; 30 acres in the $NW\frac{1}{4}SW\frac{1}{4}$; 80 acres in the $S\frac{1}{2}SW\frac{1}{4}$; 36 acres in the $NE\frac{1}{4}SE\frac{1}{4}$; 80 acres in the $W\frac{1}{2}SE\frac{1}{4}$ and 40 acres in the $SE\frac{1}{4}SE\frac{1}{2}$ of Section 3, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 10: 10 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$; 5 acres in the SE $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 29; 40 acres in the NE $\frac{1}{2}$ NW $\frac{1}{4}$; 40 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$; 36 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and 5 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 28, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 11: 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$; 36 $\frac{1}{2}$ acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$; 40 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ and 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 5, Township 2 South, Range 45 East of Willamette Meridian. (Supplemented by water from Farmers Ditch)

Tract No. 12: 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ and 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 8, Township 2 South, Range 45 East of Willamette Meridian. (40 acres of the above described land - 10 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ and 30 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ are supplemented by water from the Dobbin Ditch.)

Tract No. 13: 160 acres in the NW $\frac{1}{4}$; 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$; 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ and 13 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 10, Township 2 South, Range 45 East of Willamette Meridian. 40 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 10, T 2 S. R. 45 E. (supplemented by Farmers Ditch)

Tract No. 14: 30 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and 5 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 22, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 15: 35 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and 38 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 16: 30 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 16, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 17: 23 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$; 4 $\frac{1}{2}$ acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$; 20 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ and 40 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 5, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 18: 12 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$; 21 $\frac{1}{2}$ acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$; 40 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and 18 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 4, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 19: 40 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$; 40 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$; 40 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and 40 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 9, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 20: 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$; 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$; 40 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$; 40 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$; 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 9, Township 2 South, Range 45 East of Willamette Meridian.

Tract No. 21: 30 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and 10 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 9, Township 2 South, Range 45 East of Willamette Meridian.

All of the above described lands being in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
