CERTIFICATE OF WATER RIGHT

This Is to Certify, That VIVIAN M. REINHARDT

of 5147 S. Side Road, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Panther Creek and seepage and Reinhardt Reservoir, constructed under Application No. R-30500, Permit No. R-1827, a tributary of Applegate River for the purpose of

irrigation of 9.4 acres

under Permit No. 24019 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 4, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second, being 0.10 cubic foot per second from Panther Creek and 0.02 cubic foot per second from seepage,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Panther Creek-NW $\frac{1}{4}$ SE $\frac{1}{4}$, Seepage-SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 23, T. 37 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1827,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre NE $\frac{1}{4}$ SE $\frac{1}{4}$
0.6 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 23
6.6 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
1.4 acre SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 24
T. 37 S., R. 6 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
