## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That VERNON JONES

of Route 4, Box 105-C, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Berkehire Slough

a tributary of Willemette River

for the purpose of

irrigation of 10 acres

under Permit No. 21,777 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from key 26, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.13** subjective per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, as projected within Riggs DIG 40, Section 14, T. 18 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightisth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.7 acre Lot 2 (SW<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>)
0.2 acre SW<sup>1</sup>/<sub>3</sub> NE<sup>1</sup>/<sub>4</sub> as projected within Riggs DIC h0
8.1 acres SE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub> as projected within Riggs DIC h0

T. 18 S., R. 3 W., W. M.

Land on which water is to be used is part of that described as follows:

East 10 acres of the following described property: Beginning at a point in the center of Berkshire Slough 14.63 chains S. 10° 42' E. from a point on the N. line of the W. L. Briggs DIC 40, T. 18 S., R. 3 W., W. M., Lane County, Oregon, which is 19.21 chains N. 89° 33' E. of the N.W. corner of said DIC; thence running S. 89° 33' W. 41.24 chains to E. line of the Southern Pacific Railway right-of-way line; thence along said line N. 19° W. 5.12 chains; thence N. 89° 33' E. 42.00 chains; thence S. 10° 42' E. 4.73 chains to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
