CERTIFICATE OF WATER RIGHT

This Is to Certify, That Fryer Ditch Association

of Eagle Point, State of Oregon, has a right to the use of

the waters of Little Butte Creek

for the purpose of Irrigation of 95.49 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 498; that the priority of the right thereby confirmed dates from See below;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.39 cubic feet per second; measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st, of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

This certificate is issued to define the water right remaining appurtenant to Tract 38, (now designated Block 2, Fryer's Addition to Eagle Point), as determined by an order of the State Engineer entered February 23, 1962 pursuant to the provisions of ORS 540.641, and supersedes certificate of water right heretofore issued to the Fryer Ditch Association on December 6, 1961, recorded at page 29168, volume 21, State Record of Water Right Certificate.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
