**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** **ARE EDIGER**

of **Route 1, Box 650, Dallas**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of an unnamed stream and reservoir constructed under Application No. R-31728, Permit No. R-2045 a tributary of **Baskett Slough (Rickreall Creek)** for the purpose of irrigation of **28.1 acres**

under Permit No. **25012** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **July 19, 1957**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.35 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$  SE $\frac{1}{4}$** , as projected within **Smith DIC 54**, Section 22, T. 7 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$  acre feet per acre** for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2045 and shall be further limited to stored water only during the period of June 1 to October 31 of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$   
0.1 acre SE $\frac{1}{4}$  SE $\frac{1}{4}$   
both as projected within I. Smith DIC 54  
Section 22  
0.8 acre NW $\frac{1}{4}$  NW $\frac{1}{4}$   
as projected within A. Shreus DIC 62  
Section 26  
20.6 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
1.0 acre SE $\frac{1}{4}$  NE $\frac{1}{4}$   
both as projected within A. Shreus DIC 62  
Section 27  
T. 7 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
