CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That CHAMBERLAIN DITCH CO., a corporation, by J. A. Crowder, Secretary, of Wallowa, State of Oregon. has a right to the use of the waters of Bear Creek, a tributary of the Wallowa River, for the purpose of the irrigation of ^{1,383.5} acres of land, domestic and stock use; and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, pages 151,152,153 and 154; that the priority of the right hereby confirmed dates from 1883 for Tracts 1,2 and 3 and from 1893 for Tracts 4,5,6,7,8,9,10,11,12,13,14,15,16,17,18,19,20,21,22,23,24, 25,26,27,28,29 and 30; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed $1\frac{1}{2}$ acre feet per acre during any period of 30 days prior to July 31st of each year; and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 80 acres in the $N\frac{1}{2}SW\frac{1}{2}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 2: 30 acres in the $SW\frac{1}{4}SW\frac{1}{4}$; 20 acres in the $SE\frac{1}{4}SW\frac{1}{4}$ of Section 10 and 35 acres in the $SW\frac{1}{4}NW\frac{1}{2}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 3: 36 acres in the $SW\frac{1}{4}SW\frac{1}{4}$ of Section 15; 40 acres in the $NE\frac{1}{4}NW\frac{1}{2}$; 22 acres in the $NW\frac{1}{4}NW\frac{1}{2}$ and 30 acres in the $SE\frac{1}{4}NW\frac{1}{2}$ of Section 22, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 4: 4 acres in the $NW\frac{1}{4}NW\frac{1}{2}$; 40 acres in the $SW\frac{1}{4}NW\frac{1}{2}$ and 40 acres in the $NW\frac{1}{4}SW\frac{1}{2}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 5: 40 acres in the $NE\frac{1}{4}SE\frac{1}{2}$ of Section 9, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 6: 2 acres in the $NW\frac{1}{4}NE\frac{1}{2}$ of Section 9 and 5 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ of Section 4, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 7: 40 acres in the $SE\frac{1}{4}SE\frac{1}{2}$ of Section 9, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 8: $17\frac{1}{2}$ acres in the $SE\frac{1}{4}NE\frac{1}{4}$ of Section 16, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 9: 10 acres in the $SE\frac{1}{4}NW\frac{1}{2}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 10: 5 acres in the $NE\frac{1}{4}NW\frac{1}{2}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 11: 19 acres in the $NE\frac{1}{4}NW\frac{1}{2}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 12: 40 acres in the $SE\frac{1}{4}SW\frac{1}{4}$; 5 acres in the $NW\frac{1}{4}SE\frac{1}{4}$ and 7 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 13: 40 acres in the $NE\frac{1}{4}NE\frac{1}{4}$ and 20 acres in the $SE\frac{1}{4}NE\frac{1}{4}$ of Section 16, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 14: 20 acres in the $SE\frac{1}{2}NW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 15: 10 acres in the $NE\frac{1}{2}NW\frac{1}{4}$; 5 acres in the $SW\frac{1}{2}NW\frac{1}{4}$ and 10 acres in the $SE\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 16: 5 acres in the $NE\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 17: 38 acres in the $SW\frac{1}{2}SW\frac{1}{4}$; 18 acres in the $SE\frac{1}{2}SW\frac{1}{4}$ and 10 acres in the $SE\frac{1}{2}SE\frac{1}{4}$ of Section 4: 14 $\frac{1}{2}$ acres in the $NE\frac{1}{2}SE\frac{1}{4}$ and 20 acres in the $SE\frac{1}{2}SE\frac{1}{4}$ of Section 5: 25 acres in the $NE\frac{1}{2}NE\frac{1}{4}$; 80 acres in the $S\frac{1}{2}NE\frac{1}{4}$; 80 acres in the $N\frac{1}{2}NW\frac{1}{4}$; 34 acres in the $SW\frac{1}{2}NW\frac{1}{4}$; 40 acres in the $SE\frac{1}{2}NW\frac{1}{4}$; 23 acres in the $NE\frac{1}{2}SW\frac{1}{4}$; 9 acres in the $SE\frac{1}{2}SW\frac{1}{4}$ and 80 acres in the $W\frac{1}{2}S\frac{1}{4}$ of Section 9: 4 acres in the $NE\frac{1}{2}NE\frac{1}{4}$ of Section 8: 30 $\frac{1}{2}$ acres in the $NW\frac{1}{2}NE\frac{1}{4}$ and 4 acres in the $SW\frac{1}{2}NE\frac{1}{4}$ of Section 16, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 18: 7 acres in the $SE\frac{1}{2}SW\frac{1}{4}$ of Section 4, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 19: 10 acres in the $NW\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 20: 20 acres in the $NE\frac{1}{2}SE\frac{1}{4}$ of Section 16, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 21: 10 acres in the $NW\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 22: 20 acres in the $SE\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 23: 14 acres in the $SE\frac{1}{2}NW\frac{1}{4}$ and 16 acres in the $NE\frac{1}{2}SW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 24: 2 acres in the $SW\frac{1}{2}NW\frac{1}{4}$ of Section 22, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 25: ~~10 acres in the $SE\frac{1}{2}NW\frac{1}{4}$~~ and 20 acres in the $NE\frac{1}{2}SW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 26: 10 acres in the $NW\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 27: 10 acres in the $NW\frac{1}{2}NW\frac{1}{4}$ of Section 15, Township 1 North, Range 42 East of Willamette Meridian,

Tract No. 28: 6 acres in the $NE\frac{1}{2}NW\frac{1}{4}$ and 6 acres in the $SE\frac{1}{2}NW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 29: 10 acres in the $SW\frac{1}{2}SW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

Tract No. 30: 17 acres in the $NE\frac{1}{2}NW\frac{1}{4}$ and 18 acres in the $NW\frac{1}{2}NW\frac{1}{4}$ of Section 10, Township 1 North, Range 42 East of Willamette Meridian.

All of the above described lands being situated in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
