CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That CITIZENS WATER DITCH CO., a corporation, by L. E. Caviness, President of Joseph, State of Oregon has a right to the use of the waters of Wallowa River, a tributary of the Grande Ronde River

for the purpose of the irrigation of 113.82 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 5, at page 155; that the priority of the right hereby confirmed dates from August 14, 1900

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: Lots and Blocks in the Town of Joseph, Oregon and adjoining tracts; and 8.69 acres in the SW 1/4 NW 1/4; 1.44 acres in the NW 1/4 SW 1/4; 0.86 acres in the SW 1/4 SW 1/4; 9.96 acres in the SW 1/4 NW 1/4 of Section 29: 4 acres in the NE 1/4 SE 1/4; 80 acres in the E 1/2 NE 1/4 of Section 30: 1.46 acres in the SE 1/4 SE 1/4; 1.29 acres in the SE 1/4 SE 1/4; 1.71 acres in the NE 1/4 SE 1/4; 1 acre in the NE 1/4 SE 1/4 and 2 acres in the SE 1/4 of Section 31: 0.58 acres in the NW 1/4 SW 1/4 and 0.83 acres in the SW 1/4 SW 1/4 of Section 32, Township 2 South, Range 45 East of Willamette Meridian, in Wallowa County, Oregon, and supplemental to lands in Section 20, Township 2 South, Range 45 East of Willamette Meridian, owned by M. J. Creighton and supplemental to lands irrigated through Farmers Ditch.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
