CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN HOCKSTRE

of **Route 1, Box 176, Dallas**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **John Hockstre Reservoir constructed under Application No. R-32278, Permit No. R-2123** a tributary of **Salt Creek (Yamhill River)** for the purpose of **supplemental irrigation of 22.8 acres**

under Permit No. **25458** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 23, 1958**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **3.5 acre feet stored water only**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within **J. Frederick DIC 38, Section 6, T. 7 S., R. 5 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre, a diversion of **2 $\frac{1}{2}$ acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 3.5 acre feet per year,**

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
as projected within J. Frederick DIC 38

as projected within J. Frederick DIC 38
4.4 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
as projected within J. Frederick DIC 38
14.0 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
as projected within J. Frederick DIC 38
Section 6
T. 7 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
