CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That COVE DITCH COMPANY, By J. W. Hayes, Secy. of Joseph, State of Oregon has a right to the use of the waters of Wallowa River, a tributary of the Grande Ronde River

for the purpose of the irrigation of 410.40 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 5, at page 157; that the priority of the right hereby confirmed dates from June 1890

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: 16 acres in the NE 1/4 NE 1/4; 35 acres in the NW 1/4 NE 1/4; 26 acres in the SW 1/4 NE 1/4; 1 acre in the SE 1/4 NE 1/4; 30 acres in the NE 1/4 NW 1/4; 40 acres in the NW 1/4 NW 1/4; 80 acres in the S 1/2 NW 1/4; 39 acres in the NE 1/4 SW 1/4; 80 acres in the W 1/2 SW 1/4; 34 acres in the SE 1/4 SW 1/4; 4 acres in the NW 1/4 SE 1/4; 12 acres in the SW 1/4 SE 1/4 and 4 acres in the SE 1/4 SE 1/4 of Section 31; 3 acres in the SW 1/4 SE 1/4 of Section 30, Township 2 South, Range 45 East of Willamette Meridian, also 6.4 acres in Lot 2 of Section 6, Township 3 South, Range 45 East of Willamette Meridian, all in Wallowa County, Oregon.

Of the above lands 35 acres in the SW 1/4 SW 1/4 and 25 acres in the SE 1/4 SW 1/4 of Section 31, Township 2 South, Range 45 East of Willamette Meridian; 2 acres in Lot 2 of Section 6, Township 3 South, Range 45 East of Willamette Meridian, are supplemented by water from the Moonshine Ditch.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
