CERTIFICATE OF WATER RIGHT

This Is to Certify, That SIDNEY IRRIGATION COOPERATIVE

of Jefferson, State of Oregon, has a right to the use of the waters of North Santiam River through the Sidney Ditch for the purpose of irrigation of 1963.1 acres and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 462; that the priority of the right thereby confirmed dates from 1870

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 35.0 cubic feet per second for irrigation and 5.0 cubic feet per second for stock use
