and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Wallowa County, and the said decree entered of record at Salem, in the Order

Record of the State Water Board of the State of Oregon, in Volume 5, at page 158;

that the priority of the right acreby confirmed dates from April 8, 1886 for Tract No. 1 and 1896 for Tract No. 2

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 12 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby con-

firmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: Tract No. 1: 23.4 acres in the SW2NE4 and 21.4 acres in the SE4NW4 of Section 9, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 2: To supplement diversion from Magill Poley-Allen ditch for the following lands also described and included above: 11.6 a cres in the $SW_{\overline{A}}^{\frac{1}{2}}NE_{\overline{A}}^{\frac{1}{2}}$ and 13.6 acres in the $SE_{\overline{A}}^{\frac{1}{2}}NW_{\overline{A}}^{\frac{1}{2}}$ of Section 9, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
