CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That the DOBBIN DITCH COMPANY, a corporation by A. W. Schaupp, Agent, of Joseph, State of Oregon, has a right to the use of the waters of Wallowa River, a tributary of the Grande Ronde River, for

the purpose of the irrigation of 2,025.2 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD, of Oregon, in Volume 5, at pages 160 and 161; that the priority of the right hereby confirmed dates from August 10,1900; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 12 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lambs irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
