**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** CLAIR SMITH HARVEY

of Rt. 1, Box 190, Gervais, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of unnamed stream (Pudding River) for the purpose of irrigation of 7.7 acres

under Permit No. G-797 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 24, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within Coonse DIC 56, Section 31, T. 5 S., R. 1 W., W. M. Well is located 1 3/4 chs. S. and 8 1/2 chs. E. from most Northerly N.W. corner, Coonse DIC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
1.2 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$   
1.0 acre SW $\frac{1}{4}$  SW $\frac{1}{4}$   
2.5 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$

all as projected within Coonse DIC 56  
Section 31  
T. 5 S., R. 1 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at an iron pipe in the center line of the County Road on the North line of the Felix Coonse DIC 4.195 chains South 88° 45' East from the most Northerly Northwest corner of said DIC; thence South 88° 45' East 5.19 chains to an iron rod; thence South 30' West 23.86 chains; thence North 88° 45' West 5.29 chains; thence North 30' East 23.86 chains to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
