**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** LEO B. SANDER

of Box 942, Tillamook, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of 2 unnamed springs and 3 unnamed streams

a tributary of Wilson River for the purpose of domestic use for one family, supplemental irrigation, stock and milk cooling, and fire protection under Permit No. 25841 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 30, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 c.f.s., being 0.01 c.f.s. from stream #1 for fire protection, 0.01 c.f.s. from stream #2 for domestic, 0.04 c.f.s. from stream #4 for supplemental irrigation, 0.01 c.f.s. from spring #3 for stock and milk cooling, and 0.01 c.f.s. from spring #6 for stock and milk cooling or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Sec. 22, T. 1 S., R. 9 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

fire protection, dom., stock 1.7 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
0.9 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 22  
0.4 acres & stock Lot 5 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 23  
T. 1 S., R. 9 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
