CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That

has a right to the use of

the waters of South Fork of Wallowa River, a tributary of Wallowa River and Wallowa River, a tributary of the Grande Ronde River

for the purpose of

the irrigation of 36 acres of land and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Wallowa County, and the said decree entered of record at Salem, in the Order

Record of the State Water Board of the State of Oregon, in Volume 5, at page 166; that the priority of the right hereby confirmed dates from 1896 for Tract No. 1 and 1890 from Tract No. 2

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed lacre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained the lands drifted under such right, and to which the water hereby con-

firmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: Tract No. 1, irrigated from South Fork of Wallowa River: Lots 1,2,3,6,7, 8,9,10,11,12,13 and 14 in Block D, Lots 13 and 14 in Block G, Town of Lostine and Lots 8,9 and 10 in Block 3, Bowmans Addition to Lostine, all in Wallowa County, Oregon.

Tract No. 2, irrigated from Wallows River: 1 acrc in the $SW_{\frac{1}{4}}^{\frac{1}{4}}NW_{\frac{1}{4}}^{\frac{1}{4}}$; 4\frac{1}{6} acres in the $SE_{1}^{\frac{1}{4}}NW_{\frac{1}{4}}^{\frac{1}{4}}$; 21 acres in the $NE_{\frac{1}{4}}^{\frac{1}{4}}SW_{\frac{1}{4}}^{\frac{1}{4}}$ and 7 acres in the $NW_{\frac{1}{4}}^{\frac{1}{4}}SW_{\frac{1}{4}}^{\frac{1}{4}}$ of Section 24, Township 1 South, Ra nge 43 East of Willamette Meridian, in Wallows County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
