under Permit No. 26364 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 1, 1959,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 ($SE_4^+SW_2^+$), Section 23, T. 7 N., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 2 (SE 3 SW 3) Section 23 T. 7 N., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point which is the intersection of the Westerly line of the relocated Columbia River Hwy. and the North line of that property as deeded to Charles H. Kelley et ux by J. R. Crabb et ux as recorded in Bk. 69, Pg. 485, Columbia Co. deed records; said point being 60 ft. Westerly of (When measured at right angles to) highway Engineer's Station 540/91.0 in Sec. 23, T. 7 N., R. 2 W., W.M.; thence along the said Westerly line of the relocated Columbia River Hwy. South 34°59' East 300.0 ft. to the true point of beginning of the following described parcel: thence South 55°01' West a distance of 200.0 ft.; thence South 34°59' East 100.0 ft.; thence North 55°01' East 200.0 ft. to the said Westerly Highway right of way line; thence North 34°59' West 100.0 feet to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
