CERTIFICATE OF WATER RIGHT

This Is to Certify, That **LLOYD LAWYER**

of Route 1, Box 252, Scappoose, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Scappoose Creek

a tributary of Scappoose Bay for the purpose of irrigation of 8.8 acres

under Permit No. 26517 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 7, 1960,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within McKay DLC 43, Sec. 1, T. 3 N., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.11 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
 1.22 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
 0.14 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$
 1.33 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$

all as projected within Malcolm McKay DLC 43
 Section 1
 T. 3 N., R. 2 W., W. M.

Land on which water is to be used is part of that described as follows:

Northerly 8.8 acres of the following described land:

Beginning at a point in the East line of the Northern Pacific Railroad right of way 33.41 chains South and 8.21 chains East of the NW corner, McKay DLC in Sec. 1, T. 3 N., R. 2 W., W.M.; thence S. 69°09'30" East 11.01 $\frac{1}{2}$ chains; thence South 20°20'20" West 13.47 chains to the South line of McKay DLC; thence N. 69°09'30" West 8.58 chains to East line of the Northern Pacific Railroad right of way; thence Northerly along East line of said right of way 13.78 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
