of Route 1, Box 660, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed slough

a tributary of Willamette River irrigation of 4.8 acres

for the purpose of

under Permit No. 26756 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1960,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SET NET, as projected within Vander art DLC 49, Section 15, T. 20 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.31 acre SW NE 2
2.07 acres SE; NE 2
2.08 acres NE 2 SE 2
0.34 acre NV SE 2
all as projected within Vandervert DIC 77
Section 15
T. 20 S., R. 3 W., W.M.

Land or which water is to be used is part of that described as follows:

Beginning at a point on the easterly line of Co. Rd. 1703.45 feet N. and 4873.76 ft. W. of the SW corner of Stanton DIC No. 51; thence South 89°42' East 730 ft. to the westerly R/W line of Hwy. 99; thence South 18°53' West along said Hwy. R/W line 338.4 feet; thence North 89°42' West 622.0 feet to the easterly line of a Co. Rd.; thence North 0°18' West 322.0 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
