under Permit No. 27368 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1961;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SE^{+}_{2}SI^{+}_{4}$, Section 27, T. 16 S., R. 2 E., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

Beginning at the meander corner on the right bank of the McKenzie River between Sections 27 and 34, T. 16 S., R. 2 E., W.M., thence S. 89°02'30" E. 255.6 feet to the Southerly right of way line of the McKenzie Highway, thence along said right of way line S. 56°54'30" E. 292.2 feet, thence N. 33°05'30" E. 80.00 feet to the Northerly right of way line of said Highway and the center line of County Road 551, also being the true point of beginning of the following described tract; running thence along the center line of County Road 551 as constructed and travelled S. 88°08'30" E. 192.0 feet, thence S. 72°03'30" E. 168.69 feet, thence leaving said County Road center line S. 22°05' W. 146.77 feet to the Northerly right of way line of McKenzie Highway, thence along said Northerly line N. 56°50' W. 328.03 feet, thence N. 56°54'30" W. 27.0 feet to the true point of beginning,
