CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWINA I. and CARL CLARKSON

of Route 3, Box 911, Coos Bay, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of _____ for the purpose of irrigation and domestic use for one family

under Permit No. 19569 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.02 cubic foot per second, being 0.01 c.f.s. for irrigation and 0.01 c.f.s. for domestic use

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 9, T. 26 S., R. 13 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.75 acre and domestic NE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 9
T. 26 S., R. 13 W., W. M.

NOTE: Certificate of water right issued to Edwina I. and Carl Clarkson and Ben Yeik and recorded at page 21283, Volume 15, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 2 acres and domestic use for two families. Subsequently, the right for the irrigation of 1.25 acres and domestic use of one family was abandoned and the certificate was cancelled by order of the State Engineer entered March 1, 1962, pursuant to the provisions of ORS 540.621. This certificate is issued to confirm the remaining right to the use of water for irrigation and domestic use and supersedes the certificate heretofore issued to Edwina I. and Carl Clarkson and Ben Yeik.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
