CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLEO BELLE and ELMER F. WILSON

of Route 1, Box 292, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Row River

a tributary of Willamette River for the purpose of

irrigation

of the State Engineer, and that said right to the use of said waters under Permit No. 25149 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 3, 1957,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE NE as projected within Cole DLC No. 39, Section 31, T. 20 S., R. 2 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.0 acres SE4 ME4 as proj. within Cole DLC 39 Section 31 0.6 acre SW4 NW4 as proj. within Cole DLC 39 Section 32 T. 20 S., R. 2 W., W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point which bears S. 1262.97 ft. and W. 906.50 ft. from the NE beginning at a point which bears S. 1202.97 ft. and W. 900.50 ft. from the NE corner, Cole DIC 39; thence S. 8°05' W. 379.30 ft., said point being the thread of channel of Row River, thence S. 51°12' W. along thread of channel of said river 146.10 ft., said point being on the W. right of way boundary line of the County Road easement; thence N. 16°52'20" W. along said road right of way boundary 108.70 ft., thence N. 73°07'40" E. 20 ft., thence N. 16°52'20" W. along said boundary line 252.70 ft., thence S. 73°07'40" W. along said boundary line 20 ft., thence N. 30° W. along said boundary an arc distance of 295.55 ft., the long chard of N. 30° W. along said boundary an arc distance of 295.55 ft., the long chord of which is 294.10 ft., thence E. 223.35 ft., thence N. 39.60 feet, thence N. 82° E. 180.84 ft., thence S. 87° E. 254.04 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described

this date.
