CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. H. P. HOWARD, JR.

of Greenwood Drive, Leaburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

McKenzie River

a tributary of Willsmette River

for the purpose of

irrigation of 5.0 acres

under Permit No. 25730 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 27, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 11, T. 17 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres Lot 1 (NE² NE¹/₄)
Section 11
T. 17 S., R. 1 E., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at the NE corner of Section 11, T. 17 S., R. 1 E., W.M., which corner is 24-ft. North of a stone marking the initial point of the Greenwood Cemetery, said section corner also being marked by a stone; from said section corner run South 740.0 feet to the Northerly bank of the McKenzie River; thence South 53° 532° West along said river bank 309.46 feet; thence leaving said river and run North 918.0 feet to the North line of said Section 11; thence North 88° 50° East along said section line 250.0 feet to the place of beginning, being a part of Lot 1 in said Section 11 in Lane County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
