CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That J. F. HAUN

of Evans, State of Oregon has a right to the use of the waters of South Fork of Wallowa River, a tributary of Wallowa River, and the Wallowa River, a tributary of the Grande Ronde River

for the purpose of the irrigation of 205.3 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 5, at page 171-2; that the priority of the right hereby confirmed dates from 1896 for Tract No. 1; 1889 for Tract No. 2; 1895 for Tract No. 3 and 1883 for Tract No. 4

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: Tract No. 1, irrigated from the South Fork of Wallowa River: Blocks 1, 2, 3 and 15: Lots 1, 2, 3, 14, 15, 16 in Block 6: S 1/2 of Block 5: Lots 3, 4, 5, 6, 7 and 8 in Block 5: Lots 1, 2, 15 and 16 of Block 8: Lots 9, 10, 11, 12, 13, 15, 16 in Block 12 in the Town of Evans in Wallowa County, Oregon.

Tract No. 2, irrigated from Wallowa River: 7 acres in the NW 1/4 NE 1/4; 19 acres in the SW 1/4 NE 1/4; 38 acres in the NE 1/4 NW 1/4; 38 acres in the NW 1/4 NW 1/4; 22 1/2 acres in the SE 1/4 NW 1/4; 37 acres in the SE 1/4 NW 1/4 and 12 acres in the NW 1/4 SE 1/4 of Section 3, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 3, irrigated from the South Fork of Wallowa River: 2.9 acres in the NE 1/4 SW 1/4 and 2 acres in the NW 1/4 SW 1/4 of Section 10, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 4, irrigated from the South Fork of Wallowa River: 10 acres in the NW 1/4 NW 1/4 of Section 10 and 10 acres in the SW 1/4 SW 1/4 of Section 3, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
