CERTIFICATE OF WATER RIGHT

This Is to Certify, That Fred W. Plueger and Florence Plueger

of Kerby, State of Oregon, has a right to the use of
 the waters of Sucker Creek, tributary of Illinois River
 for the purpose of irrigation of 2.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
 Josephine County, and the said decree entered of record at Salem, in the Order Record of
 the STATE ENGINEER, in Volume 1, at page 252; that the priority of the right thereby
 confirmed dates from 1857

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
 amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second

A description of the lands irrigated under such right, and to which the water is appurtenant
 (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

2.5 acres in the NE 1/4
 Section 35
 T. 39 S., R. 8 W., W.M.

being within the tract of land described as follows:

Beginning at a point 20 rods North of the Southwest corner of the
 Northeast Quarter of the Southeast Quarter of Section 35, Township 39
 South, Range 8 West of the Willamette Meridian, and running thence East
 270 feet to the West line of the Holland-Bridgeview Road as now located;
 thence Northerly 443 feet along the West line of said Road; thence North-
 westerly along the West line of said Road to the point where the West
 line of said Road intersects the West line of said Northeast Quarter of
 the Southeast Quarter of said Section 35; thence South 809 feet to the point
 of beginning, Josephine County, Oregon. Less and excepting any portion
 lying within roads.

Note: This Certificate is issued to correct and supersede that certain
 water right certificate heretofore issued to William M. Bunch and recorded
 in State Record of Water Right Certificates, Volume 7, page 7126, so as
 to correctly describe that portion of said right presently owned by Fred
 W. Plueger and Florence Plueger as directed by Decree of the Circuit
 Court for Josephine County dated October 22, 1962, and Order amending
 said Decree dated November 27, 1962.

And said right shall be subject to all other conditions and limitations contained in said decree.
 The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
 use herein described.
