CERTIFICATE OF WATER RIGHT

This Is to Certify, That Sarah Higdem

of Kerby

, State of Oregon

, has a right to the use of

the waters of Sucker Creek, tributary of Illinois River

for the purpose of irrigation of 0.5 acre

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Josephine County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 1, at page 252; that the priority of the right thereby
confirmed dates from 1857

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

O.5 acre in the NEtSEt Section 35
T. 39 S., R. 8 W., W.M.

being within the tract of land described as follows:

Beginning at a point 20 rods North of the Southeast corner of the Northeast Quarter of the Southeast Quarter of Section 35, Township 39 South, Range 8 West of the Willamette Meredian, and running thence North 384 feet; thence West 1030 feet, more or less, to the East line of the Holland-Bridgeview Road, as it is now located; thence Southerly 384 feet along the East line of said road; thence East 1024 feet to the point of beginning. LESS AND EXCEPT: Beginning at a point from which the Quarter Section corner between Sections 35 and 36, Township 39 South, Range 8 West of the Willamette Meridian bears North 587.6 feet distant and being the Northwest corner of the tract of land conveyed to A. J. Houck and wife by deed recorded in Book 112 at page 456; thence South 89° 28' West 749.2 feet; thence South 3° 10' East 165.5 feet; thence North 87° 40' West 292.7 feet; thence South 3° 14' East 203 feet; thence South 78° 47' East 163.2 feet; thence North 88° 03' East 372 feet; thence North 89° 35' East 494.8 feet to a point which is the Southeast corner of the aforementioned Houck Tract; thence North 382.3 feet to the point of beginning.

Note: This Certificate is issued to correct and supersede that certain water right certificate heretofore issued to William M. Bunch and recorded in State Record of Water Righ Certificates, Volume 7, page 7126, so as to correctly describe that portion of said right presently owned by Sarah Higdem as directed by Decree of the Circuit Court for Josephine County dated October 22, 1922, and Order amending said Decree dated November 27, 1962.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
