Willamette River a tributary of irrigation of Li.7 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters 26791 under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1960,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.18 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEZ SEZ, Section 23, T. 17 S., R. 1 N., N. M. (through Walterville Canal).

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres SW4 SW4 as projected within Storment DLC 40 Section 22 4.7 acres NW4 NW4 as projected within Storment DLC 40 Section 27 T. 17 S., R. 1 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on N. R/W line of Eugene Power Canal, said point being 158 ft. S. 89° E. from a point on the W. line of Sec. 27, T. 17 S., R. 1 W., W.M., said last mentioned point being S. 0°01' E. 435 ft. from NW corner, Sec. 27, from said beginning point run N. 0°01' W. 1658.87 ft. to the N. line of the grantor's land, the description of which is recorded in Vol. 103, p. 256, Lane Co. Deed land, the description of which is recorded in vol. 105, p. 250, hanc to been Records, thence N. 89°36' E. along said N. line likely ft., thence leaving said N. line and run S. 17°05' E. 450.52 ft., thence N. 89°30' E. 1100.62 ft., thence S. 11°16' E. 1169.02 ft. to the Northerly R/W line of McKenzie Hwy., thence Westerly along said hwy. R/W line and of the Eugene Power Canal R/W line as follows: S. 61°05' W. 117.88 ft., thence N. 89° W. 354.1 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
