## CERTIFICATE OF WATER RIGHT

This Is to Certify, That LYLE BOWERS

of Route 1, Box 126, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bowers Well No. 1

a tributary of Santiam River for the purpose of irrigation of 8.0 acres

under Permit No. G-1352 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 18, 1959,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Klum DLC 40, Section 32, T. 12 S., R. 1 W., W. M. Well located South 0°15' West 18.7 chains from NE corner, Klum DLC No. 40.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.2 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
 1.8 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
 both as projected within Klum DLC 40  
 Section 32  
 T. 12 S., R. 1 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on the East boundary line of the Klum DLC 40, which is 16 rods South of the NE corner of said claim, and running thence West 20.00 rods; thence South 60.00 rods; thence Southeasterly 20.00 rods, more or less, to the East line of said claim; thence North on the East line of said claim 68.00 rods to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
