CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That the HURRICANE CREEK IRRIGATING DITCH COMPANY, a corporation, by S. P. Crow, Secretary, of Lostine, State of Oregon, has a right to the use of the waters of Hurricane Creek, a tributary of the Wallowa River, for the purpose of the irrigation of 1,283 acres of land, domestic and stock use and the development of 2 horsepower, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, pages 174 and 175; that the priority of the right hereby confirmed dates from 1883; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes; and shall not exceed  $1\frac{1}{2}$  acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season for irrigation, domestic and stock and 2.2 cubic feet per second for power; and said rights shall be subject to all other conditions and limitations contained in said decree.

A description of the land irrigated under such rights, and to which the water hereby confirmed is appurtenant, or if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 40 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  and 40 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 23, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 2: 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 26; 80 acres in the S $\frac{1}{2}$ SF $\frac{1}{4}$  of Section 23; 30 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  and 40 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 24, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 3: 5 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 35, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 4: 25 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 35, 40 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  and 80 acres in the W $\frac{1}{2}$ SE $\frac{1}{4}$  of Section 26, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 5: 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 40 acres in the SF $\frac{1}{4}$ NE $\frac{1}{4}$  and 80 acres in the E $\frac{1}{2}$ SF $\frac{1}{4}$  of Section 26, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 6: 37 $\frac{1}{2}$  acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 35, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 7: 5 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 38 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 37 acres in the SF $\frac{1}{4}$ NW $\frac{1}{4}$ ; 35 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  and 35 acres in the SF $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 23, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 8: 37 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 14 and 40 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 23, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 9: 31 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  and 28 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 14; 40 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ ; 35 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ ; 2 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  and 3 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 23, Township 2 South, Range 44 East of Willamette Meridian. Overshot wheel in NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 23, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 10: 32 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ ; 20 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ ; 40 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 14; 1 acre in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  and 21 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 13, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 11: 33 $\frac{1}{2}$  acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 24; 40 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 32 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  and 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 23 Township 2 South, Range 44 East of Willamette Meridian.

All of above described land being in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
