of Box 8. Turnel Road. Glendale , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Tunnel Creek

a tributary of Cow Creek

for the purpose of

irrigation of 2.4 acres

under Permit No. 26111 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 8, 1959.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.03 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 NE_4^1 , Section 4, T. 33 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3½ acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to the use of water is limited to the period when the flow of water in Cow Creek is 11.0 c.f.s. or more at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.4 acres SE¹ NE¹ Section 4
T. 33 S., R. 6 W., W. M.

Land on which water is to be used is part of that described as follows:

Situated in the S¹₂ of the NE¹₄, Section 4, T. 33 S., R. 6 W., W.M. Beginning at a point 42.5 feet North of the quarter corner between Sections 3 and 4, T. 33 S., R. 6 W., W. M.; thence North a distance of 612.0 feet to a point in the South fence line of the county road; thence South 55° 0' West a distance of 652.3 feet to a point at the junction of two roads; thence South 66° 00' East, following the fence on the North side of the road southward a distance of 584.8 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
