**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That JOHN F. STANEK**

of **Star Route, The Dallas**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Eightmile Creek**

a tributary of **Fifteenmile Creek** for the purpose of **Supplemental irrigation of 14.8 acres**

under Permit No. **5692** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **November 15, 1922,**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

**0.19 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 4, T. 1 N., R. 14 E., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.7 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$   
0.1 acre SE $\frac{1}{4}$  SW $\frac{1}{4}$   
Section 4  
0.3 acre NE $\frac{1}{4}$  NW $\frac{1}{4}$   
9.3 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$   
2.4 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 9  
T. 1 N., R. 14 E., W. M.

This certificate is issued to confirm a change in place of use and point of diversion, approved by an order of the State Engineer entered September 19, 1962, pursuant to the provisions of ORS 540.510 to 540.530, and supersedes certificate of water right heretofore issued to Leon W. Curtiss and D. P. Ketchum, and recorded at page 5329, Volume 6, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
