CERTIFICATE OF WATER RIGHT

This Is to Certify, That CECIL S. and VERL E. WOODS

of Star Route, Dexter , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Lot Creek for the purpose of irrigation of 1.2 acres

under Permit No. G-1103 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 1, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within McCall DLC No. 39, Section 8, T. 19 S., R. 1 W., W. M. Well located 25 feet South and 475 feet East from SE corner, Fisher DLC No. 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre NW $\frac{1}{4}$ NW $\frac{1}{4}$
As projected within J. Morgan DLC 51
0.2 acre NW $\frac{1}{4}$ NW $\frac{1}{4}$
0.2 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
Both as projected within McCall DLC No. 39
Section 8
T. 19 S., R. 1 W., W. M.

This certificate is issued to correct and supersede that certain water right certificate issued to Cecil S. and Verl E. Woods on November 22, 1960, and recorded in State Record of Water Right Certificates, Volume 20, page 27813, so as to correctly show the location of the well.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
