that the priority of the right hereby confirmed dates from 1891 for Tract No. 1; 1896 for Tract No. 2 and 1889 for Tract No. 3

that the amount of water to which such right is entitled and hereby confirmed for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed \mathbf{l}_{2}^{1} acre feet per acre during any period of 30 days prior to July 31st of each year. and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby con-

firmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use,

is as follows: Tract No. 1: 33 acres in the $\mathfrak{M}_{q}^{-1}SE_{q}^{-1}$; 34.6 acres in the $SE_{q}^{-1}SE_{q}^{-1}$ of Section 9 and 11 acres in the SWISWI of Section 10, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 2: 40 acres in the $NW_4^1SF_4^1$ and 34 acres in the $SW_4^1SE_4^1$ of Section 5 and 34.6 acres in the NW 2 NW of Section 9, Township 1 South, Range 43 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 3: 80 acres in the $S_{\overline{z}}^1 N W_4^1$; 80 acres in the $N_{\overline{z}}^1 S W_4^1$; 15 acres in the SWASWA and 40 acres in the SE SWA of Section 32, Township 1 North, Range 43 East of Willamette Meridian, in Wallows County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
