CERTIFICATE OF WATER RIGHT

This Is to Certify, That ZIMMERMAN BROTHERS

of **Route 1, Box 278, Stayton**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Detroit Reservoir**

a tributary of **Willamette River** for the purpose of **supplemental irrigation of 111.3 acres**

under Permit No. **24312** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **July 16, 1956,**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

278 acre feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, T. 10 S., R. 5 E., W. M.** **Diversion from river: Lot 1 (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 11, and Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 13, T. 9 S., R. 1 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **_____ of one cubic foot per second per acre** a diversion of **2 $\frac{1}{2}$ acre feet per acre** or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed **278 acre feet per year**; and is subject to the terms of Contract No. **11-06-100-1010**, dated March 30, 1956, between the United States of America through the Bureau of Reclamation and the applicant, a copy of which is on file in the office of the State Engineer,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
