CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLYDE W. FENIMORE

of Route 6, Box 158, Lakeview, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Fenimore Well No. 2

a tributary of Drews Creek for the purpose of irrigation of 223.9 acres

under Permit No. U-753 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 13, 1955,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

2.80 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 19, T. 40 S., R. 19 E., W. M. Well located 1370 feet North and 50 feet East from South $\frac{1}{4}$ corner, Section 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to Clyde W. Fenimore and recorded at page 26902, Volume 19, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 250.9 acres. Subsequently, the right to the use of water appurtenant to 27.0 acres was canceled by order of the State Engineer entered May 23, 1963. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Clyde W. Fenimore.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
