CERTIFICATE OF WATER RIGHT

This Is to Certify, That IRVING J. MacDONALD

of **Myrtle Creek** , State of **Oregon** , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **South Myrtle Creek**

a tributary of **Myrtle Creek of South Umpqua River** for the purpose of **irrigation of 22.0 acres**

under Permit No. **26061** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **February 16, 1959,**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.28 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within Carson DIC No. **42**, Section **30**, T. **29 S.**, R. **4 W.**, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$** acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of water in the South Umpqua River is **60.0 c.f.s.** or more at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
6.4 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.3 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 19
0.7 acre NW $\frac{1}{4}$ NE $\frac{1}{4}$
11.4 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
0.2 acre NW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 30

All as projected within Carson DIC **42**
T. **29 S.**, R. **4 W.**, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
