CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DORNEY J. PEARSON

of Route 1, Riddle , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Conneil Creak

a tributary of Cow Creek

domestic use of one family and irrigation of 1.2 acres

of the State Engineer, and that said right to the use of said waters 26973 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 25, 1960,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.02 cubic foot per second, being 0.01 c.f.s. for domestic and 0.01 c.f.s. for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW No. 18 Section 4, T. 31 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 32 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of Cow Creek is more than 11.0 c.f.s. at its mouth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 1.2 acres and Domestic NW NW NW Section 4 T. 31 S., R. 6 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at the NW corner of Section 4, T. 31 S., R. 6 W., W. M.; thence East along the North boundary of said Section 4 a distance of 290.6 feet; thence South 13 40 West 51.0 feet; thence South 7 10 West 41.0 feet; thence South 1 20 East 260.5 feet; Thence South 8 00 West 37.5 feet; thence South 15 30 West 114.8 feet; thence South 36° 20' West 66.0 feet; thence South 46° 20' West 77.8 feet; thence South 37° 30' West 60.0 feet; thence South 52° 50' West 140.3 feet to the West boundary of said Section 4; thence North 737.7 feet along the West boundary of said Section 4 to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
