CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PAUL D. GREEN

of Star Route, Dexter , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Middle Fork Willemette diver, Alder Creek and Green's Reservoir constructed under Application number R-32921, Permit number R-2220, for the purpose of Willemette River

irrigation of 4.0 acres and fish culture

under Permit 1.0. 25983 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 18, 1959,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.55 cubic foot per second, being 0.05 c.f.s. for irrigation and 0.50 c.f.s. for fish culture,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 36, T. 18 S., R. 2 W., W. M., and Lot 3 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 31, T. 18 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ons-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-2220, water to be diverted from Alder Creek when available and any deficiency in the available supply in Alder Creek is to be made up by diversion from Middle Fork Willamette River, providing that the total quantity diverted from both streams shall not exceed one-eightieth of a cubic and shall foot per second for each acre irrigated conform to such reasonable rotation system as mdy be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres Lot 2 (SE¹/₄ NE¹/₄)

Fish and 2.0 acres Lot 3 (NE¹/₄ SE¹/₄)

Section 36

T. 18 S., R. 2 W., W. M.

Fish Lot 3 (SW¹/₄ SW¹/₄)

Section 31

T. 18 S., R. 1 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
