## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

, has made proof 2130 "A" Street, Forest Grove , State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bearwallow Gulch and a reservoir constructed under Application number R-21319. Permit number R-923,

a tributary of Pine Creek for the purpose of

irrigation of 17.8 acres and supplemental irrigation of 45.0 acres

18112 of the State Engineer, and that said right to the use of said waters, under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 8, 1945.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.57 cubic feet per second, being 0.32 c.f.s. from gulch and 1.25 c.f.s. from reservoir,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW NE , Section 28, and SW NE , Section 33,, T. 7 S., R. 46 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1 to October 1 from direct flow, and shall be further limited to a diversion of not to exceed 1 acre foot per acre for each acre irrigated during the month of July, 1 acre foot per acre for each acre irrigated during the month of August, and one-half of one acre foot per acre for each acre irrigated during the month of September from direct flow and storage from a reservoir constructed under Permit number R-923.
