CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That JOHN McDONALD

of Wallowa, State of Oregon has a right to the use of the waters of Bear Creek, and the South Fork of Wallowa River, tributaries of Wallowa River

for the purpose of the irrigation of 120 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 5, at pages 183-184; that the priority of the right hereby confirmed dates from 1907 for Tract No. 1; 1887 for Tract No. 2; 1893 for Tract No. 3 and 1896 for Tract No. 4

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1 1/2 acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: Tract No. 1: To supplement the water diverted through the City of Wallowa ditch for the following described lands: 8 acres in the SE 1/4 NE 1/4 of Section 15, Township 1 North, Range 42 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 2: 30 acres in the SW 1/4 NE 1/4; 30 acres in the SE 1/4 NE 1/4 and 10 acres in the NW 1/4 SE 1/4 of Section 10, Township 1 North, Range 42 East of Willamette Meridian, in Wallowa County, Oregon.

Tract No. 3: 34 acres in the SW 1/4 NW 1/4 of Section 14 and 8 acres in the SE 1/4 NE 1/4 of Section 15, Township 1 North, Range 42 East of Willamette Meridian, in Wallowa County, Oregon. (8 acres of above described land supplemented by water through McNutt ditch)

Tract No. 4: All of Block 7, Lots 6, 7 and 8 in Block 9, Lots 6,7,8,9, 10 and 11 in Block 8, Town of Lostine, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
