## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MELVIN OLFERT

of Route 1, Box 110, Dallas , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and Nelvin Olfert Reservoir constructed under Application No. R-32338, Permit No. R-2115, a tributary of Baskett Slough for the purpose of

irrigation of 6.7 acres

under Permit No. 25530 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 21, 1958,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.8 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE<sup>1</sup><sub>4</sub> NE<sup>1</sup><sub>4</sub>, as projected within Brown DIC No. 64, Section 28, T. 7 S., R. 5 7, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to the use of stored water only during the period of June 1 to October 31 of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
