CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That the MOONSHINE DITCH COMPANY, a corporation, by Geo. L. Cole, President, of Joseph, State of Oregon, has a right to the use of the waters of Hurricane Creek, a tributary of the Wallowa River, for the purpose of the irrigation of 705.34 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 5, at pages 186 and 187; that the priority of the right hereby confirmed dates from 8 A. M. November 30, 1901; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed $1\frac{1}{2}$ acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Tract No. 1: 35 acres in the $SW\frac{1}{4}SW\frac{1}{4}$ of Section 31, Township 2 South, Range 45 East of Willamette Meridian. (Supplemented by Cove Ditch)

Tract No. 2: 40 acres in the $NW\frac{1}{4}SE\frac{1}{4}$ and 7 acres in the $SW\frac{1}{4}NE\frac{1}{4}$ of Section 36, Township 2 South Range 44 East of Willamette Meridian.

Tract No. 3: 40 acres in the $SE\frac{1}{4}NW\frac{1}{4}$; $34\frac{1}{2}$ acres in Lot 5 ($SW\frac{1}{4}NW\frac{1}{4}$) 27 acres in the $SW\frac{1}{4}NE\frac{1}{4}$ and 24 acres in the $NW\frac{1}{4}SE\frac{1}{4}$ of Section 6, Township 3 South, Range 45 East of Willamette Meridian.

Tract No. 4: 47.6 acres in Lot 3 ($NE\frac{1}{4}NW\frac{1}{4}$) and 77.6 acres in Lot 4 ($NW\frac{1}{4}NW\frac{1}{4}$) of Section 6, Township 3 South, Range 45 East of Willamette Meridian.

Tract No. 5: 16 acres in the $NE\frac{1}{4}SW\frac{1}{4}$ and $1\frac{1}{2}$ acres in Lot 6 ($NW\frac{1}{4}SW\frac{1}{4}$) of Section 6, Township 3 South, Range 45 East of Willamette Meridian.

Tract No. 6: 15 acres in the $SE\frac{1}{4}SE\frac{1}{4}$ of Section 35; $36\frac{3}{4}$ acres in the $SW\frac{1}{4}SW\frac{1}{4}$ and 40 acres in the $SE\frac{1}{4}SW\frac{1}{4}$ of Section 36, Township 2 South, Range 44 East of willamette Meridian. (35 acres of above land in $SE\frac{1}{4}SW\frac{1}{4}$ of Section 36 is supplemented by water from Robin Boner ditch from Hurricane Creek)

Tract No. 7: 40 acres in the $SW\frac{1}{4}SE\frac{1}{4}$ and 40 acres in the $SE\frac{1}{4}S\frac{1}{4}$ of Section 36, Township 2 South, Range 44 East of Willamette Meridian. 20.07 acres in Lot 1; 20.07 acres in Lot 2; 39 acres in Lot 7 ($NW\frac{1}{4}NE\frac{1}{4}$); 37 acres in Lot 8 ($NE\frac{1}{4}NE\frac{1}{4}$); 3 acres in Lot 9 ($SE\frac{1}{4}NE\frac{1}{4}$); 2 acres in Lot 10 ($SW\frac{1}{4}NE\frac{1}{4}$) of Section 1, Township 3 South, Range 44 East of Willamette Meridian.

Tract No. 8: 40 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, Township 2 South, Range 44 East of Willamette Meridian.

Tract No. 9: 12 $\frac{1}{2}$ acres in Lot 3 and 10 acres in Lot 6 (NW $\frac{1}{4}$) of Section 1, Township 3 South, Range 44 East of Willamette Meridian.

All of the above described land being in Wallowa County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
