CERTIFICATE OF WATER RIGHT

This Is to Certify, That **DAVID M. & SARA K. WELCH, ROBERT K. & MARY SCOTT HAMMONS, TRUMAN D. & Z. IDELLE COLLINS and J. B. BRISTOW**

of Box 572, Tioga, State of North Dakota, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean
irrigation of 30 acres

for the purpose of

under Permit No. 8776 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 7, 1928,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Sec. 15 for Welch & Collins; Lot 4, Sec. 10 for Hammons; and Lot 3, Sec. 10 for Bristow; all in T. 34 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
