CERTIFICATE OF WATER RIGHT

This Is to Certify, That THOS. J. JOHNSON

of Eagle Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of _____ for the purpose of irrigation of 14.5 acres

under Permit No. 8572 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1928,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 16 and NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 21, both in T. 34 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
 7.5 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
 3.6 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$

Certificate of water right recorded at page 10540, State Record of Water Right Certificates confirms a right to the use of water for irrigation of 19 acres. Subsequently the point of diversion for irrigation of 2.4 acres was transferred by order of the State Engineer entered February 26, 1963 and the right to the use of water for the irrigation of 2.1 acres was canceled by order of the State Engineer dated October 14, 1963. This certificate is issued to confirm the remaining right to the use of water and also confirms a change in point of diversion approved by an order of the State Engineer entered April 11, 1947 as amended pursuant to the provisions of ORS 540.510 to 540.530.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
