## CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. A. BRADLEY

of Milton-Freewater, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of spring branch

a tributary of Walla Walla River for the purpose of irrigation of 208.0 acres and domestic use

under Permit No. E-8 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16, 1909,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.607 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 24, T. 6 N., R. 35 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to J. A. Bradley and recorded at page 957, Volume 2, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 213.0 acres. Subsequently, the right to the use of water appurtenant to 5.0 acres was cancelled by order of the State Engineer entered August 23, 1963. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to J. A. Bradley.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
