## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** MARGARET HECK

of c/o Frontier Enterprises, Inc. Cottage Grove State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River

a tributary of Willamette River for the purpose of irrigation of 4.2 acres

under Permit No. 16195 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 28, 1945,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.052 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Cochren DIC 55, Section 28, T. 20 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.2 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
3.0 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
both as projected within Cochren DIC 55  
Section 28  
T. 20 S., R. 3 W., W. M.

Land on which water is to be used is to be used is part of that described as follows:

Lot 5 Division of Robert Cochren Estate

NOTE: Certificate of water right issued to Margaret Heck and recorded at page 17101, Volume 14, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 9.7 acres. Subsequently the right to the use of water for the irrigation of 0.8 acres was canceled by order of the State Engineer entered November 19, 1963 and the point of diversion for the irrigation of 4.7 acres was transferred by order of the State Engineer dated November 20, 1963. This certificate is issued to confirm the remaining right and supersedes the certificate heretofore issued to Margaret Heck.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
