CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAMS & SKOPIL, ATTORNEYS AT LAW

of Pioneer Trust Bldg., Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek

a tributary of Willamette River for the purpose of irrigation of 2.7 acres and fire protection

under Permit No. 15313 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 9, 1941,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second, being 0.03 c.f.s. for irrigation and 0.03 c.f.s. for fire protection

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW¹/₄ SW¹/₄, as projected within Elevens DLC No. 49, Section 27, T. 7 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Fire protection and 0.6 acres NW¹/₄ SW¹/₄
Fire protection and 2.1 acres SW¹/₄ SW¹/₄
Both as projected within Elevens DLC No. 49
Section 27
T. 7 S., R. 4 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered October 22, 1962 pursuant to the provisions of ORS 540.510 to 540.530, and together with the certificate recorded at page 30337, Volume 22, supersedes certificate of water right heretofore issued to Elza K. Chancellor Spilane and recorded at page 15825, Volume 13, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
